Maribeth Opperman introduced our speaker, Amy Card. She is the director of the Sarah Bush Lincoln Health Foundation. The foundation is a not-for-

profit organization rooted in the community, raising funds and collaborating with others to support the Health System's mission *to* provide exceptional care for all and create healthy communities. The foundation is led by a 20-member board consisting of individuals from the communities served by SBL.

Amy's topic today is the Willow Breeze SBL Hospice House, recently built for \$8 million. The facility has three levels of care – General Inpatient Care, Residential Care, and Respite Care. There are eight private suites with patio, library, chapel, activity room, family quiet rooms, and a walking path.

The staff includes a medical director, registered nurses, hospice aides, social worker, bereavement counselor, spiritual counselor, and volunteers. Most health insurances cover the cost of hospice care, they do not cover the cost of room and board. The foundation helps patients who can't afford the costs.

Jerry Reynolds introduced our speaker, Dan Meyer. He farms and is a new member of the Illinois Corn Marketing Board (ICMB). ICMB was established in 1982 to manage

the voluntary checkoff investment that corn Illinois farmers agreed to implement. The farmers that serve on the board are elected by their peers to serve unpaid three-year terms. These ICMB farmer leaders strategically invest Illinois corn checkoff dollars to grow demand, create new markets, and foster understanding of corn farmers and the corn industry, which is Illinois' highest valued agricultural commodity.

Dan shared his photos and experiences from a ICMB trip to Vietnam and Thailand. Vietnam's focus was on aquaponics. Catfish is a crop that is raised for domestic use and export. The focus in Thailand was dairy. With irrigation, three crops per year can be raised to provide silage for the cows.

The seven farmers in the group visited farms and a feed mill. They were given a short while to visit sights in Bangkok such as the huge Reclining Buddha.

It was very hot during the trip. Food was interesting, but generally very good. Dan was glad to have had the learning opportunity in those countries.

2. KI Dues Increase Effective 10-1-24 –

Kiwanis International dues have not increased since 2015. KI has concentrated on reducing expenses over the last few years...i.e. 13% staff reduction, 40% travel reduction, and more. At the Kiwanis International Convention in Denver, on July 6, 2024, the Kiwanis club delegates approved a dues increase of \$25.00 effective 10-1-24. Each club is billed for 2024/2025 in October 2024. The club collects dues each year in advance...January 31 and July 31.
